The Fulshear Farmers' Market is a farmers' market operated by Forever Fulshear; it complies with all federal, state, county and city regulations. Admittance to the market depends on approval by the Fulshear Farmers Market Management Team created by Forever Fulshear to manage the market. In general, vendors must sell products grown or produced by the vendor within 200 miles of Houston, hold ALL required permits, licenses, and insurance policies necessary for their business operation, sign the indemnity agreement included in this vendor application holding Forever Fulshear and the Fulshear Farmers' Market harmless, and pay daily market fees.

Over time, these rules may be amended and updated to reflect and address the unique aspects, needs and requirements of the Fulshear Farmers' Market.

Each vendor will be required to pay a day fee of \$35, per stall space for each market attended and will be forfeited if the vendor cancels after Wednesday of the week they are expected to attend. A white tent and, at least, four 20 pound tent leg weights are required. 10x10 tents are available for rent at \$15 per Market day. Please inquire to the Market Manager. A \$35 deposit is required upon acceptance to the Market. Each week the vendor is at the market, there will be a fee per 10x10 booth space that will be determined by the market management team. This fee is due a week in advance. Vendors acknowledge that these fees may change per the Market Committee’s request.

Vendor has read and understands the Market Rules for the Fulshear Farmers’ Market and is bound by the terms and conditions outlined herein. Vendors may sell only what is listed on this application, and any additional items that a vendor would like to sell must be reviewed by the market committee.

Vendors are responsible for the quality and safety of what they sell.

We, the undersigned, agree to comply and abide by the rules and regulations of the Fulshear Farmers’ Market program. This agreement admits the producer under the same terms and conditions as other participating producers, and does not constitute permission to participate if the market’s rules and conditions are violated.
